Estate Taxes and Other Tax Changes

Potentially effecting retirees and people who may pass after 2020.



Whatever your political affiliation or philosophies, a new administration always brings big changes. As is always our mantra, "plan for the worst, hope for and work toward the best", the following article explains in great detail how these changes would effect you or your parents. **Long and short, in**Massachusetts, anyone with a cumulative estate value of \$1M or more should at least consider some or a full estate tax minimization plan, as that is the Massachusetts threshold. (As an aside, MA is one of only 13 states that has a state "estate" tax and MA has the lowest threshold at \$1M, tied with Oregon, while other state thresholds increase to \$7M). The bigger exposure as it relates to estate tax thresholds is that the current \$11M federal estate tax threshold may be decreased to \$3.5M.
